



Hans Christian Joachim Gram (1850 – 1938), was a Danish bacteriologist. The work that gained him international reputation was his development of a method of staining bacteria. In 1884, he developed a method for distinguishing between two major classes of bacteria. This technique, the Gram stain, continues to be a standard procedure in medical microbiology.
